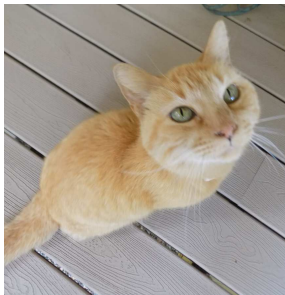

Personal watercraft on Locke Lake:

There has been a significant increase in personal watercraft on Locke Lake this year. Please be aware of the laws to prevent hazardous conditions and the Wright County Sheriff and DNR from visiting our lake for violations!

PERSONAL WATERCRAFT OWNERS/USERS – PLEASE READ:

Locke Lake has seen a rise with personal watercraft usage. There have been several violations of the personal watercraft laws this summer. The main violation is operating the watercraft outside the operation times defined by law. By law, operation of personal watercraft is allowed only from 9:30 a.m. to 1 hour before sunset.

- For example, August 1 has a sunset time of 8:39 p.m. This means that personal watercraft should NOT be operated after 7:39 p.m.
- On September 1, sunset is at 7:48 p.m. This means that personal

watercraft should NOT be operated after 6:48 p.m.

- Operation of personal watercraft is allowed only from 9:30 a.m. to 1 hour before sunset.

It is unsafe and against the law to operate personal watercraft outside of these hours. Please do not do it and do not allow your guests to do it.

Personal Watercraft Laws:

- Anyone operating or riding on a personal watercraft must wear a U.S. Coast Guard- approved wearable life jacket that is compatible with that activity (check the label).
- Personal watercraft must travel at slow no- wake speed (5mph or less) within 150 feet of non-motorized boats, shore (unless launching or landing skiers directly to or from open water); docks, swim rafts, swimmers, or any moored or anchored boat.
